The aim of the 6FP project eGOVERNMENT is to coordinate the creation of national eGovernment RTD programmes/initiatives, as well as to stimulate the integration of existing national eGovernment programmes.

## **The background of the workshop initiative**

The development of eGovernment would benefit from a clearer picture and better understanding of the needs of eGovernment research in the regions. Due to the nature of eGovernment research (multi-disciplinary, a large variety of stakeholders, huge potentials in many sectors, etc.) there is a lack of well-founded analysis on how the research in eGovernment should be managed. Fragmented research-funding mechanisms, low visibility and low, or absent, trans-national coordination of national and regional eGovernment-research policies are some of the obstacles. This workshop is part of the work in facing these problems and built an international knowledge and agenda for eGovernment research management.

## **Topic and areas addressed by the workshop**

The workshop will address a broader perspective on needs of eGovernment research in the regions and penetrate some areas in more detail. Input from the expertise of the participating audience will be welcomed and highly valued.

## **The broader perspective on eGovernment research management needs**

- What are the major challenges of regional eGovernment RTD programme implementation? Recourses necessary? Knowledge gaps? Organisational weaknesses? Obstacles related to culture and tradition?
- Which research areas contribute to the development of eGovernment RTD programmes?

The workshop programme includes presentations of both research findings and practical experiences, aiming to stimulate the discussion and to provide an interdisciplinary approach to the questions above.

A report on the findings of the workshop will be published on the eGOVERNMENT website ([www.egovernnet.org](http://www.egovernnet.org)) together with the case studies, once these have been validated in the workshop.
